

Big investor-owned power companies bypassed rural areas because they believed they could not generate enough profit. Frequent meetings among neighbors were had to discuss the formation of the cooperative. Once established, the cooperative (7220037.03 Christine A. Anderson) was committed to provide the community with electricity.

Today, Red Lake Electric currently serves about 5,400 members. We have returned almost \$12 million to our members since 1938.

## Understanding the seven cooperative principles

Cooperatives around the world operate according to the same set of core principles and values, adopted by the International Co-operative Alliance. Cooperatives trace the roots of these principles to the first modern cooperative founded in Rochdale, England, in 1844. These principles are a key reason that America's electric cooperatives operate differently from other electric utilities, putting the needs of their members first.



#### 1. Open and Voluntary Membership

Membership in a cooperative is open to all persons who can reasonably use its services and stand willing to accept the responsibilities of membership, regardless of race, religion, gender, or economic circumstances.

#### 2. Democratic Member Control

Cooperatives are democratic organizations controlled by their members, who actively participate in setting policies and making decisions. Elected representatives (directors/trustees) are elected from among the membership and are accountable to the membership. In primary cooperatives, members have equal voting rights (one member, one vote); cooperatives at other levels are organized in a democratic manner.

#### 3. Members' Economic Participation

Members contribute equitably to, and democratically control, the capital of their cooperative. At least part of that capital remains the common property of the cooperative. Members (5820001.02 Edward E. Braaten) allocate surpluses for any or all of the following purposes: developing the cooperative, setting up reserves, benefiting members in proportion to their transactions with the cooperative, and supporting other activities approved by the membership.

#### 4. Autonomy and Independence

Cooperatives are autonomous, self-help organizations controlled by their members. If they enter into agreements with other organizations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control as well as their unique identity.

#### 5. Education, Training, and Information

Education and training for members, elected representatives (directors/trustees), CEOs, and employees help them effectively contribute to the development of their cooperatives. Communications about the nature and benefits of cooperatives, particularly with the general public and opinion leaders, helps boost cooperative understanding.

#### 6. Cooperation Among Cooperatives

By working together through local, national, regional, and international structures, cooperatives improve services, bolster local economies, and deal more effectively with social and community needs.

#### 7. Concern for Community

Cooperatives work for the sustainable development of their communities through policies supported by the membership.

#### Cheesy Cream Cheese Hamburger Casserole

 1 lb. ground beef
 1/2 small green pepper, diced
 1/2 small red pepper, diced
 1/2 medium onion, chopped
 2 medium garlic cloves, minced
 8 oz. cream cheese, at room temp or microwave for a minute to soften
 1 cup sour cream
 1 cup parmesan cheese
 1 cup cheddar cheese or mozzarella
 12-oz. pasta of your choice cooked al dente
 3 cups pasta sauce
 salt and pepper to taste

Preheat your oven to 350°. In a large skillet over medium-high heat, saute the hamburger and cook until almost cooked through. Add the onion, peppers, garlic salt, pepper and pasta sauce. Cook until the veggies are cooked through.

In a medium saucepan, boil water for pasta. Add pasta and cook until pasta is just al dente. Do not overcook as the pasta will continue to cook in the oven. Drain.

Add the cream cheese. If you didn't leave it out at room temperature, you can microwave it for a minute. Add sour cream and parmesan cheese.

In a sprayed 9x13 casserole dish, add the pasta mixture. Then add the hamburger mixture on top and stir until everything is loosely combined. Top with the shredded cheddar or mozzarella.

Bake at 350° for 25-30 minutes or until the casserole is heated through. Serve immediately.

## **Operation Round Up® grants total \$12,850**

he Red Lake Electric Trust board met recently and awarded 15 grants to area nonprofit and community organizations totaling \$12,850. Since its inception in 1993, 838 Operation Round Up grants totaling \$538,000 have been gifted to area community organizations. The Red Lake Electric Trust receives money for grants from the Operation Round Up program administered by Red Lake Electric Cooperative. Today, 94 percent of Red Lake Electric's members voluntarily "round up" their monthly bill for the Operation Round Up program.

#### The following two organizations were awarded Round Up funds to help the disadvantaged.

- Violence Intervention Project of Thief River Falls: \$1,000 for its Umbrella Tree Program that provides (4313001.03 Travis Harbott) supervised child visitations.
- Red Lake County Victim Services: \$500 to help with expenses for victims of a crime.

### Four area emergency service providers were awarded grants.

• Goodridge Fire and Rescue: \$1,500 to help purchase Armor radios and a computer.

- Red Lake Falls Volunteer Ambulance Service: \$2,000 to help purchase LED light bar for ambulance.
- Viking Fire and Rescue: \$700 to help upgrade supplies for first responders and ambulance.
- Plummer Volunteer Fire Department: \$1,500 to help purchase handheld radios.

Monies to benefit the youth were awarded to these seven organizations:

- Early Childhood Family Education (Red Lake County): \$400 to help fund field trip for parents and preschool aged children.
- Marshall County Social Services: \$750 to support Christmas sharing tree and food basket projects.
- Red Lake County Holiday Gift Program (Salvation Army): \$500 to purchase Christmas gifts for its annual Holiday program.
- Safety Camp (TRF & Pennington County): \$500 to help purchase safety equipment and safety camp supplies.
- Christmas for Pennington County: \$500 to help purchase Christmas gifts for its annual Holiday program.
- Little Brother / Little Sister Program (TRF): \$1,000 to support active matches through activities and monthly check-ins and recruitment.

• Power of Produce Club: \$500 to provide vouchers to children to expose them to fresh produce and shopping at a Farmers Market.


*Two organizations that provide help and service to area seniors received the following grants:* 


- LSS Senior Nutrition Program (Red Lake Falls): \$1,000 to help provide low-income seniors with meals.
- Middle River Community Living at Home/Block Nurse Program: \$500 to help with transportation cost to bring seniors to medical appointments.

The RLE Trust Board of Directors determines grants two times per year, in March and September. Serving on the board are: Tishara Melcher - president, Middle River; Diane Kolstoe - vice president, Oklee; and Julie Stennes - secretary/treasurer, Thief River Falls; ex-officio directors are Bonnie Christians of Crookston and Stephanie Johnson of Gatzke, representing Red Lake Electric Cooperative. The next deadline for Operation Round Up grant applications is February 22, 2019.



# GUNS AND POWER LINES

Hunting is a Minnesota favorite, ranking right up there with the fishing opener. Before you head out to the tree stand, review these hunting safety tips:

- ✓ Treat every firearm as if it were a loaded firearm.
- ✓ Be sure of your target before you pull the trigger. When you look through the sight, look beyond your target. Make sure there isn't another hunter in your sight or a building or structure, such as an electric facility.
- ✓ Never point a firearm at anything you don't intend to shoot.
- ✓ Never shoot at electric power lines or electric facilities such as substations or transformers. Not only is it extremely dangerous, but it is also against the law.
- ✓ Always carry a firearm so that the muzzle is under control.
- ✓ Firearms must always be unloaded when carried into camp or not in use.
- ✓ Make sure the barrel and action are clear of obstruction.
- ✓ Unattended firearms must be unloaded.
- ✓ Never climb a fence or ditch with a firearm. Never (4436006.02 Douglas Torblaa) climb into a tree stand with a loaded firearm remove the ammunition first.
- ✓ Never shoot at flat, hard surfaces or the surface of water. The bullet can hit the surface and travel parallel to it for a long distance.
- ✓ If you see a power line on the ground, don't touch it! Touching an energized power line could kill you. Notify the local utility of a downed line as soon as possible.
